



In the future if you wish to stop receiving your bank account information electronically, you may un-enroll in the E-Statement Section under the Options Tab in NetTeller or you may notify us in writing at the address listed above. Until that time this addendum agreement will remain in effect. By enrolling, you agree to the terms stated above and are able to meet the minimum requirements for printing or retaining the information that is provided to you. You understand that you have a duty to exercise reasonable promptness in examining the electronic statement or the items referenced to determine whether any payment was not authorized because of an alteration of an item or because a purported signature by or on behalf of you or other signatory on the account was not authorized.
